"A.S.D. DOLOMITICA SPORT TRENTO" in collaboration with "U.S. CARISOLO" the latter affiliated to the Italian Athletics Federation (FIDAL) with code TN569 organizes the 6<sup>th</sup> edition of the Dolomitica Run Half Marathon Val Rendena, a 21.0975 km road race (approval n. ITA/2025/147) included in the FIDAL national calendar.

The race will take place on Sunday 13 September 2026 with

- **Departure:** 10:30 am, Corso Trento, Pinzolo (TN)
- **Arrival:** Sesena Sports Centre, Tione di Trento (TN)

#### **PARTICIPATION REQUIREMENTS:**

According to the provisions of the "Rules for the organization of events" issued by FIDAL, all athletes who belong to one of the following categories can participate:

**1. Italian and foreign athletes registered for 2026 for FIDAL affiliated clubs** from 18 years onwards (year of age 2008);

**2. Athletes registered with foreign federations affiliated to World Athletics**

By submitting, if they are not registered by their Federation or Club or Assistant, a special form of self-declaration of membership.

Non-EU athletes must present a residence permit or entry visa.

Athletes belonging to foreign Federations that require authorization to compete abroad (rule 4 of the International Technical Regulations) must present the authorization itself.

**3. Italian and foreign athletes registered with a club affiliated to a Sports Promotion Body affiliated with FIDAL only in possession of RUNCARD-EPS Athletes in possession of Runcard or Runcard EPS**

Italian and foreign citizens can participate, limited to people from 20 years of age (year of age: 2006) onwards, members of a club affiliated (athletics discipline) to a Sports Promotion Body affiliated with FIDAL in possession of a valid RUNCARD-EPS (date not expired) issued directly by FIDAL.

**Please note:** possession of the RUNCARD is not sufficient. Participation is still subject to the control of the possession of an adequate medical certificate (i.e. medical certificate of specific competitive fitness for Athletics (no other wording) valid. The medical certificate required by these regulations must be uploaded to the DataHealth portal via the ENDU.net portal, no later than 10 days before the race. To be validated, it must be considered compliant with the participation requirements of the event. These athletes will be regularly included in the race rankings, but will not be able to enjoy refunds, bonuses or access to the prize pool.

**4. Italian and foreign RUNCARD holders residing in Italy**

Italian citizens and foreigners residing in Italy can participate, limited to people aged 20 years and over (year of age: 2006) onwards, who are not members of a club affiliated to FIDAL or a foreign athletics club affiliated to World Athletics, in possession of a valid RUNCARD (date not expired) issued directly by FIDAL.

**Please note:** possession of the RUNCARD is not sufficient. Participation is still subject to the control of the possession of an adequate medical certificate (i.e. a valid medical certificate of specific competitive fitness for Athletics (no other wording). The medical certificate required by these regulations must be uploaded to the DataHealth portal via the ENDU.net portal, no later than 10 days before the race. To be validated, it must be considered compliant with the participation requirements of the event. These athletes will be regularly included in the race rankings, but will not be able to enjoy refunds, bonuses or access to the prize pool.

## 5. Foreign and Italian RUNCARD holders NOT residing in Italy

Foreign citizens and Italians not resident in Italy can participate, limited to people aged 20 years and over (year of age: 2006) onwards, not registered for a club affiliated to FIDAL or for a foreign athletics club affiliated to World Athletics, in possession of a valid RUNCARD (date not expired) issued directly by FIDAL.

**Please note:** possession of the RUNCARD is not sufficient. Participation is in any case subject to the verification of the possession of an appropriate medical certificate (see below for certificate specifications), it is necessary to download this form, to be filled in, signed and stamped by your doctor:

The medical certificate required by these regulations must be uploaded to the DataHealth portal via the ENDU.net portal, no later than 10 days before the race. To be validated, it must be considered compliant with the participation requirements of the event. These athletes can present a medical certificate issued in their own country, but compliant with the diagnostic tests required by Italian legislation (Ministerial Decree 18/02/82) in order to carry out competitive activities – see below:

- Medical
- Complete urine test
- Electrocardiogram at rest and after exercise
- Spirography

All statements and test reports must be authentic or conform to the originals.

These athletes will be regularly included in the race rankings, but will not be able to enjoy refunds, bonuses or access to the prize pool.

## 6. Foreign athletes not resident in Italy (EXCLUSIVELY FOR TOURIST-SPORTING PURPOSES)

Only foreign athletes who are at least 18 years of age on the date of the event may participate, without sending a medical certificate as they are foreign citizens who are not registered and not resident in Italy. They are required to duly complete the Liability Waiver Form when registering.

These are considered foreign athletes who are “foreign citizens who are not registered members” and will be listed in alphabetical order of arrival, separate from the competitive event rankings. They will not be eligible for prizes in kind, cash, vouchers, bonuses, fees or expense reimbursements of any kind.

This non-competitive event for tourism/sporting purposes does not fall under the auspices of FIDAL.

### IMPORTANT WARNINGS:

- Copies of medical certificates can be uploaded online during the registration procedure or sent as an attachment to [dolomiticarun@evodata.it](mailto:dolomiticarun@evodata.it);
- Athletes who do not have the RUNCARD can subscribe to it at the following web address [www.runcard.com](http://www.runcard.com);
- Athletes registered with other Federations (e.g. Italian Triathlon Federation) or Sports Promotion Bodies recognized by CONI can participate in compliance with the rules provided for the categories referred to in point 3 and point 4 (RUNCARD-EPS / RUNCARD + competitive medical certificate with the wording Athletics);
- The medical certificates must bear the wording of "competitive sports fitness for the practice of ATHLETICS". Medical certificates issued for other sports or with wording such as "running", "running", "marathon" or "half marathon" are not valid for the purposes of participation;
- RUNCARD and RUNCARD-EPS cards are renewable. The card shows the expiry date of the card. If, during the check of the card, it is found that it has expired, the athlete can NOT participate, unless a receipt of the online renewal is presented.

## REGISTRATION FEES:

1. For the first 100 subscribers promotional fee € 22.00 ONLINE
2. At the end of the first fee until 31.03.2026 € 26.00 ONLINE
3. from 01.04.2026 to 31.05.2025 € 30.00 ONLINE
4. from 01.06.2026 to 31.07.2026 € 35.00 ONLINE
5. from 01.08.2026 to 09.09.2026 € 40.00 ONLINE
6. late registrations from 12.09.2026 to 13.09.2026 € 45.00 (in the race office during opening hours)

For club promotion every 10 members + 1 free

The cost of the online registration service (not dependent on the organization) is not included in the fees indicated.

The participation fee includes:

- Race bib with disposable chip
- race pack
- Medical assistance
- storage and transport of personal clothing from departure to arrival
- finisher medal
- refreshments along the way
- refreshments on arrival
- Pasta Party Voucher
- Shuttle bus from arrival to departure

## BIB ASSIGNMENT:

The bib numbers will be assigned progressively depending on the date of registration. Those registered by 30/08/2026 will receive the personalization of the bib with their name automatically.

The starting grid will be determined on the basis of the "personal best time" declared by the participants during registration (by 30/08/2025 at the latest) and achieved in the last 4 years in an official FIDAL half-marathon.

The personal best time can be updated online directly by the athlete by being part of their registration.

The organizer reserves the right, at its sole discretion, to assign an advanced grid to deserving athletes (e.g. times in the marathon, 10,000 m, etc.).

## CLOSING OF REGISTRATIONS:

Online registrations will be closed at the end of 11:59 pm on 09.09.2026 or when 1000 participants are reached. The organizer reserves the right to close registrations early or to accept registrations after the closing date at its sole discretion.

Registration is accepted only by simultaneous payment of the amount.

## FEE REFUND:

If a competitor does not participate in the race, he is not entitled to a refund of the registration fee paid.

Participation fees are non-refundable under any circumstances. However, the registered athlete who is unable to take part in the race is offered the possibility of transferring the registration to another person. It is possible to transfer the registration to another person by making a request no later than 31.08.2026 by paying a supplement of € 10.00 for secretarial fees. The person registered as a replacement must provide all personal information and information relating to the membership or medical certificate. The fee of € 10.00 must be paid by bank transfer, with bank charges to be paid by the payer, made out to A.S.D. Dolomitica IBAN: IT03A 0807 8352 6000 0029 0112 46 at Cassa Rurale Adamello Giudicarie Val Sabbia Paganella with the reason for payment "substitution (name surname) \_\_\_\_\_ with (name surname) \_\_\_\_\_".

If the race is cancelled, moved to another date and/or, in any case, not held due to force majeure, including pandemic and natural events, not dependent and/or not attributable to the will of the Organisers, including the revocation of the authorisation to carry out by the competent Public Bodies, for any reason, the participant will have nothing to claim from the organiser, not even by way of reimbursement of the expenses incurred by validating the signing of the application for registration also as a waiver of any claim for compensation for damage and/or indemnity and/or any claim for reinstatement and/or satisfaction of any financial damage suffered and suffered.

#### **CATEGORIES & RANKINGS:**

- Overall female and male ranking
- Female and male by categories
- Super team larger group

In the Super team, largest group ranking, the athletes of each ranked club are counted.

#### **The awarded categories and special prizes**

It is a good idea to be personally present to collect the prize, which will not be sent home.

Prizes are not subject to exchange

The prizes must be equal men and women for the same route, in international and national road races 25% of the prize money must be reserved for Italian athletes, art. 38 of the Rules for the Organization of Events 2025.

\*The 25% prize money will not be awarded for performances greater than 1h11'00 in the men's ranking and 1h23'00 in the women's ranking.

NB: Runner-up athletes will be included in the ranking but will not be able to benefit from cash prizes (or value vouchers, bonuses, engagements, reimbursement of expenses, etc.).

#### **GENERAL CLASSIFICATION**

The first 5 classified in the men's and women's general classification will be awarded, these will be excluded from category prizes.

Male 1st 400.00 €, 2nd 250.00 €, 3rd 200.00 €, 4th 100.00 €, 5th 50.00 €

Female 1st 400.00 €, 2nd 250.00 €, 3rd 200.00 €, 4th 100.00 €, 5th 50.00 €

Italian athletes and equivalents Male/Female\* 1st 120.00 €, 2nd 80.00 €, 3rd 50.00 €

Super Team Rewards 1st 300.00 €, 2nd 200.00 €, 3rd 100.00 €

### **AGE CATEGORIES**

The first 3 classified in each male and female age category will be awarded starting from the Juniors 18-19 up to the Seniors 70, 5-year-old categories.

For the MF/MM 75 and 80 categories, prize for the first in the category. (awards in kind)

### **AWARD CEREMONY:**

2.00 p.m. – Sesena Sports Center in Tione di Trento.

### **PATH:**

km 21.0975, The entire route is paved.

### **TIME LIMIT:**

The time limit to finish the race is set at 3h00'.

### **REFRESHMENTS:**

Drinks are distributed: water, tea, energy drinks, every 5km along the route and on arrival. A sponge service will also be set up in case of high temperatures.

### **CHANGING ROOMS AND SHOWERS:**

At the arrival point of the race at the Sesena Sports Center in Tione di Trento - opening on Sunday from 09:30.

### **TRANSPORT MODE:**

A shuttle bus service will be available from arrival to departure from 13:00 to 17:00.

### **RACE BIB:**

The race bib must be attached to the chest in a clearly visible way. The bib number is personal and cannot be used by any other person. The bib must be collected personally. Race bibs and race packs can also be collected by third parties, with a written proxy (on a special form provided by ENDU which will be delivered by email when confirming registration), a confirmation letter from the delegating party and a photocopy of a valid identification document. If an athlete does not deliver the missing documentation for the possible regularization of the registration, he will not be able to collect the bib which will not be refunded and will only be able to collect the race pack.

### **BAG STORAGE:**

Together with the bib, a bag with an identification number showing your race number will be delivered to be applied in a clearly visible way to it. The bag must contain only the personal clothing of the participants to be used for the post-race change and will be the only container accepted by the organization, it will be collected, kept and returned at the end of the race at the reserved space "Athletes' bag deposit" set up at the finish line at the Sesena Sports Center in Tione di Trento. It is advisable not to leave personal belongings (mobile phone, wallet, etc.) inside the bags, the organization cannot be held responsible for any theft, loss or damage.

## **COMPLAINTS:**

Any complaints must be submitted within 30 minutes of the presentation of the rankings in the first instance verbally to the Referee at the races and in the second instance in writing to the Appeal Judge, accompanied by the fee of € 100.00, which will be returned if the complaint is accepted. For anything not expressly provided for in these regulations, please refer to the general regulations of FIDAL. The Competition Judges Group will be able to disqualify athletes who do not pass through the detection points located along the route.

## **FRAUDULENT PARTICIPATION IN THE TENDER – SANCTIONS:**

The registered participant is responsible for the ownership and custody of his/her race bib, acquiring the right to use all the services mentioned in these regulations and subsequently communicated.

a) Anyone who, without regular registration, participates without a bib, in addition to being held responsible for damage to persons or property, including himself, will incur sporting sanctions under the competence of the federal bodies and may be liable to the criminal sanctions provided for the crime of "theft" (art. 624. of the Criminal Code).

b) Anyone who, without regular registration, participates with a counterfeit bib or in any case that does not comply with the assignment, in addition to being responsible as indicated above, will incur sporting sanctions and, in addition, may be liable to the criminal sanctions provided for the crime of "theft" (art. 624. of the Criminal Code), or, alternatively, for the crime of "fraud" (art. 640 of the Criminal Code).

In cases a) and b) participants may be liable to the penalties provided for the crime of "non-compliance with the provisions of the Authorities" (Article 650 of the Criminal Code). The above cases will be verifiable only after verification of photographic and/or video documentation.

## **RESPONSIBILITY:**

The organizing company declines any and all responsibility for accidents and damage to athletes, third parties and property, before, during and after the event. For anything not covered by these regulations, the rules of the G.G.G., the technical regulations of FIDAL, the provisions of the WA and the laws in force are in force. The competition is covered by third-party liability insurance.

## **PRIVACY LAW:**

Law 13 of the GDPR 2016/679 (General Data Protection Regulation, European Regulation on the protection of personal data). In full compliance with the provisions of the law on the protection of personal data, the data requested with registration will be processed exclusively for the normal secretarial activity of the race indicated above, as well as for any proposals and communications relating to the activities of the Dolomitica Organizing Committee.

**VARIOUS:**

The Organizing Committee reserves the right to modify these regulations in all its parts, subject to communication and approval by the Regional Committee and National FIDAL, for the changes that will be made to the FIDAL regulations and for reasons that it deems appropriate for a better organization of the race.

By registering for the Dolomitica Run 2026, participants accept the rules of these regulations and thus express their knowledge of them.

**IMAGE RIGHT:**

By signing the registration form, the competitor expressly authorizes the organizers to use the images, still and/or moving, that portray him during his participation in the Dolomitica Run 2026 free of charge. The organizers may transfer to their institutional and commercial partners the rights of use of the image provided for in this agreement. This authorization to use one's image must be understood to be given for an indefinite period, in compliance with the laws, regulations and treaties in force and without territorial limits throughout the world; for use in various publications and films, including, but not limited to, promotional and/or advertising materials made on all media.

**WASTE:**

It is strictly forbidden to throw rubbish along the way. Participants are invited to maintain a decent attitude during the race and during the starting operations.
